




If you already have a scheduling system or HRA in place, we provide intuitive Excel upload functionality to match appointments and HRA information in our system.




**For screeners**, Clovi provides an intuitive web and mobile app for event management and data collection. Data is securely sent, over SSL, to Clovi's HIPAA-compliant cloud servers.

Once a measurement is saved, Clovi provides real-time feedback on the individual risk ranges, allowing the screener to offer instant, personalized feedback to the participant.




Eligibility files can be uploaded prior to the event with 100% matching. After the event, collected data can be exported into Excel or integrated, via RESTful APIs, to third party wellness portals. We also provide ability to instantly print results or email.




## CloviWell - product for end-users

Once the data is collected, it's vital to communicate the results to employees and employers.

**For employees,** Clovi provides instant real-time results in the web and mobile app. The results are color-coded according to well-defined risk ranges, associated with educational material, and personalized with notes from the screener. If this is a returning employee, their historical test results will be available and comparable to current results.



**For employers,** Clovi provides instant real-time aggregate reports that are specific to an event, as well as over-time. The employer can filter and sort by specific metrics to get actionable insights from the data.

Clovi is a HIPAA-compliant cloud software platform built and run by engineers who believe security is our core business value. When talking about security and privacy, we break the conversation into four stages:



All communication with Clovi goes through HTTPS. Our servers are only available via HTTPS.

Our HIPAA servers encrypt all records with 256-bit AES encryption keys. Every record is encrypted with a unique initialization vector by a unique encryption key to achieve semantic security. Clovi verifies each record's integrity on a regular basis and on each record request using a hash-based authentication code (HMAC) calculated using its own unique 256-bit HMAC key. Encryption keys, initialization vectors and HMAC keys are rekeyed and each record re-encrypted on a regular basis.

Clovi's HIPAA infrastructure comprises multiple VPN and VPC subsystems. Each subsystem is totally and completely segmented from one another by software and network security rules to maximize protection. Each subsystem can only be accessed by another subsystem via specific network routes and specific inbound and outbound port rules. Below, we share a diagram of the infrastructure.
